The House met one hour thirteen minutes behind stipulated sitting schedule

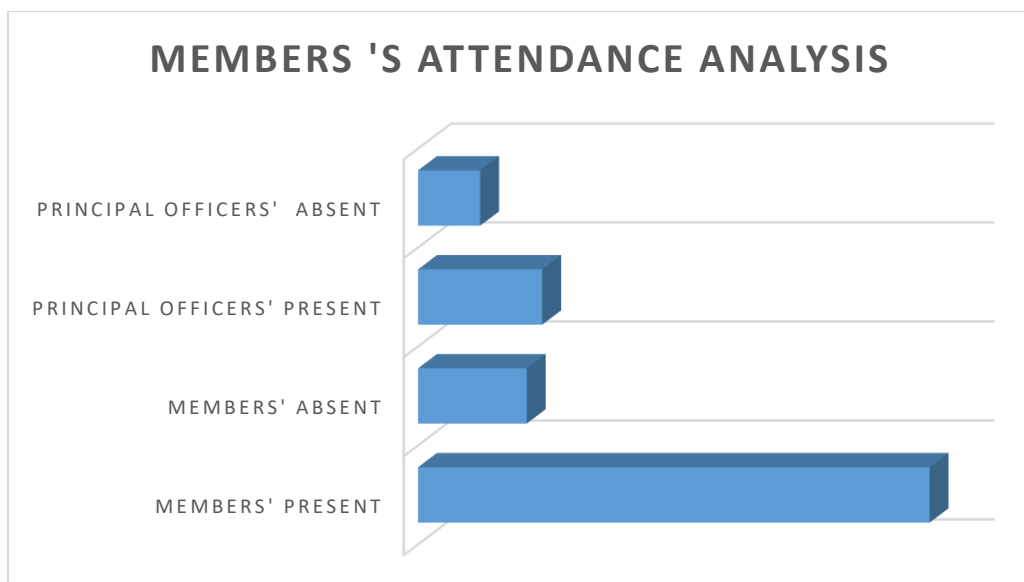

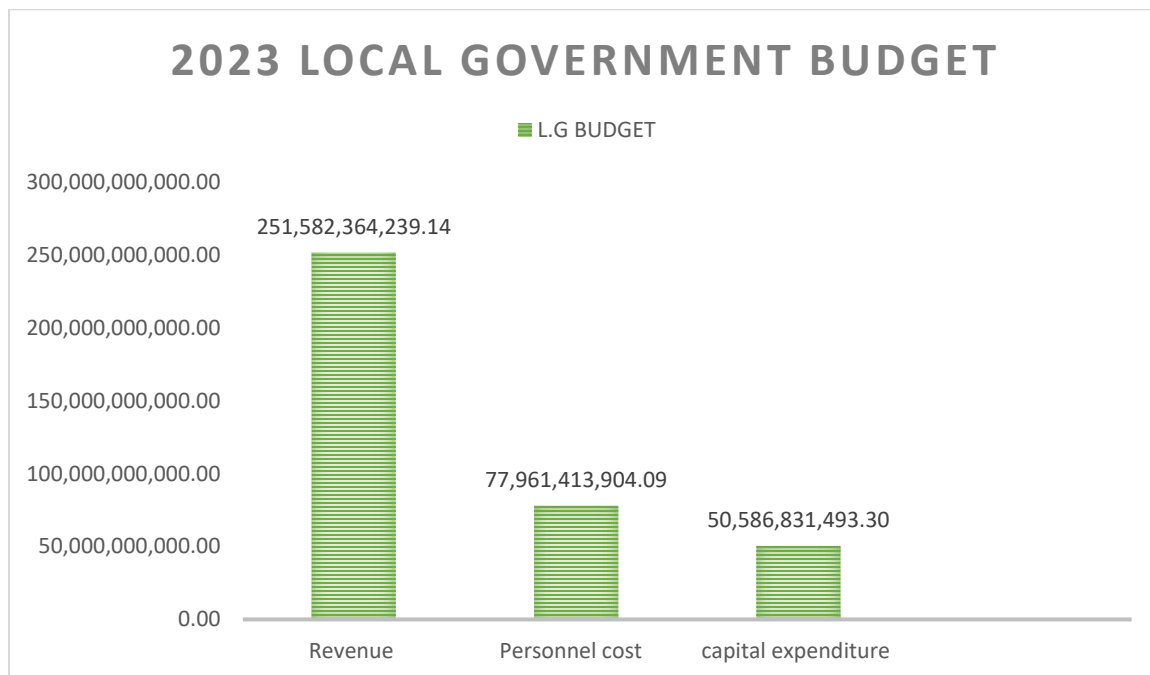

- The total amount for the projected *Revenue* for the 44 Local Governments is **N251,582,364,239.14**
- The total Personnel cost for the 44 Local Government is **N77,961,413,904.09**
- The total allocated overhead cost is **N50,586,831,493.30**
- The capital expenditure is **123,034,118,841.75**
- Total Expenditure **251,582,364,239.14**

- The personnel cost is higher than that of Capital expenditure under review by N273,745,824,10

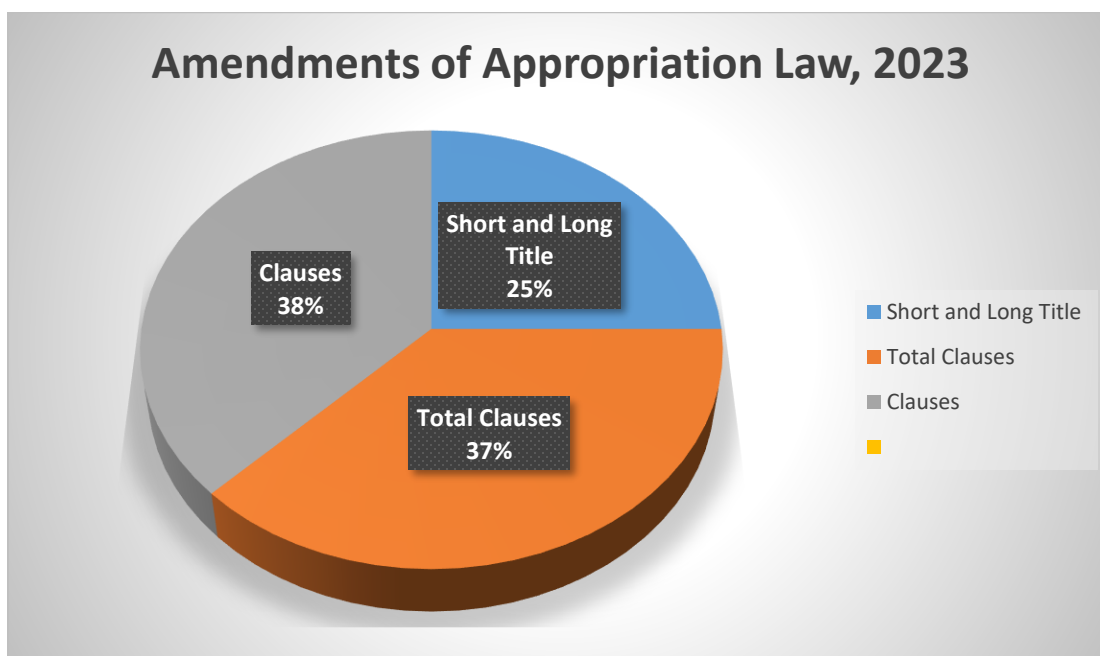

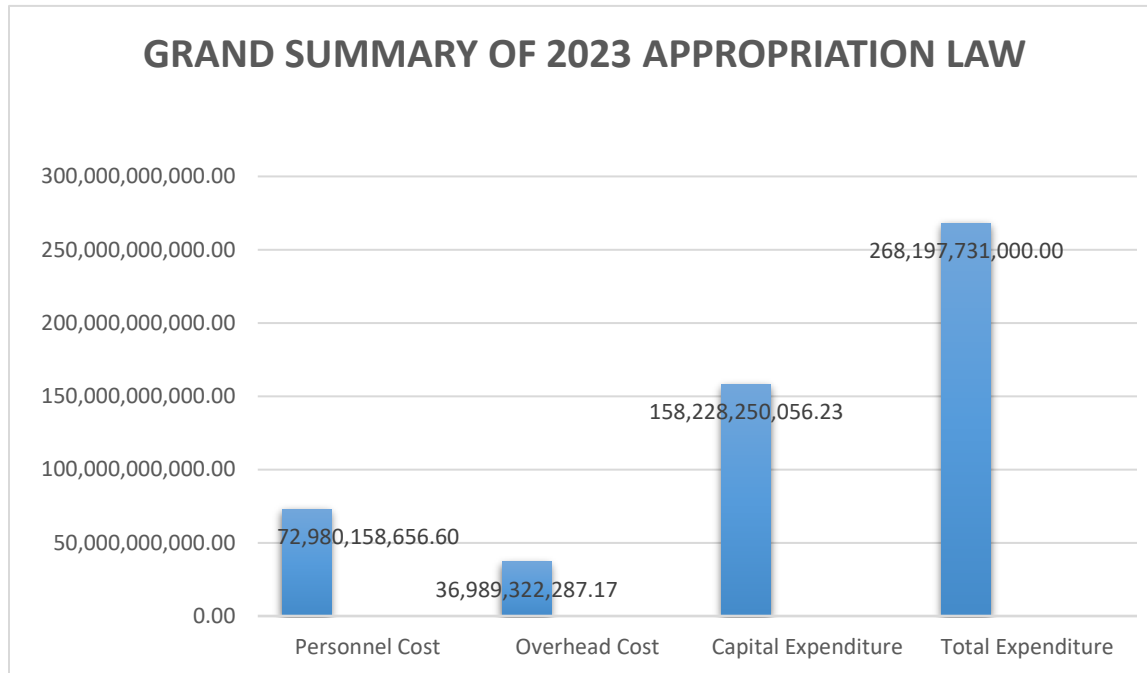

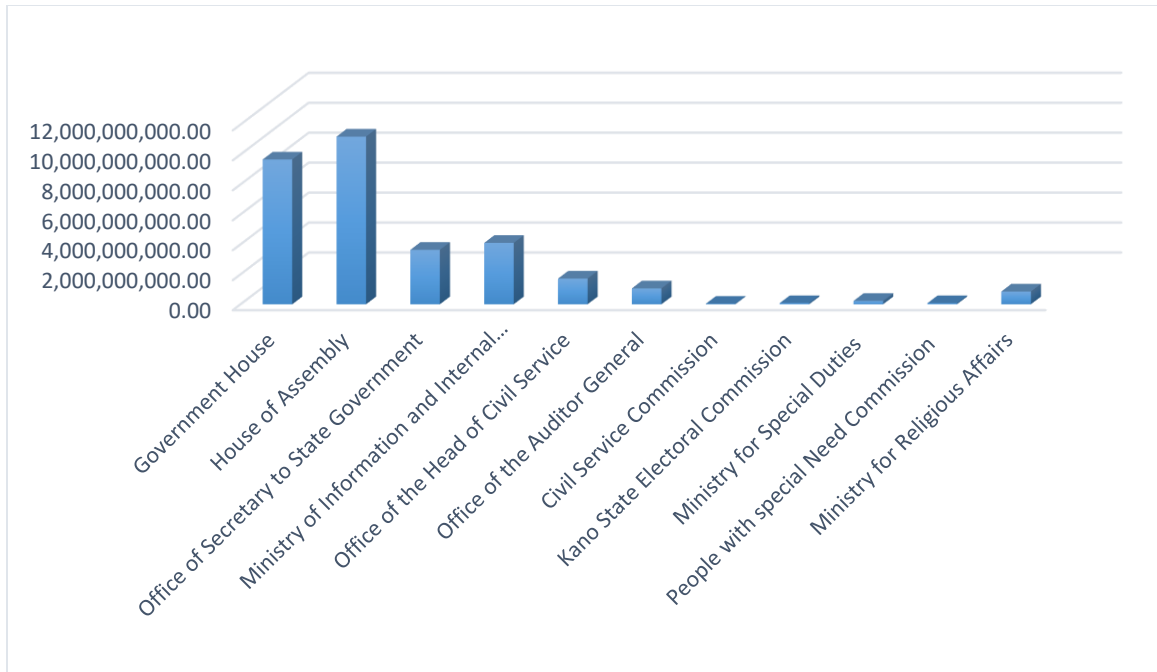
ANALYSIS.

- The total Expenditure is **268,197,731,000.00**

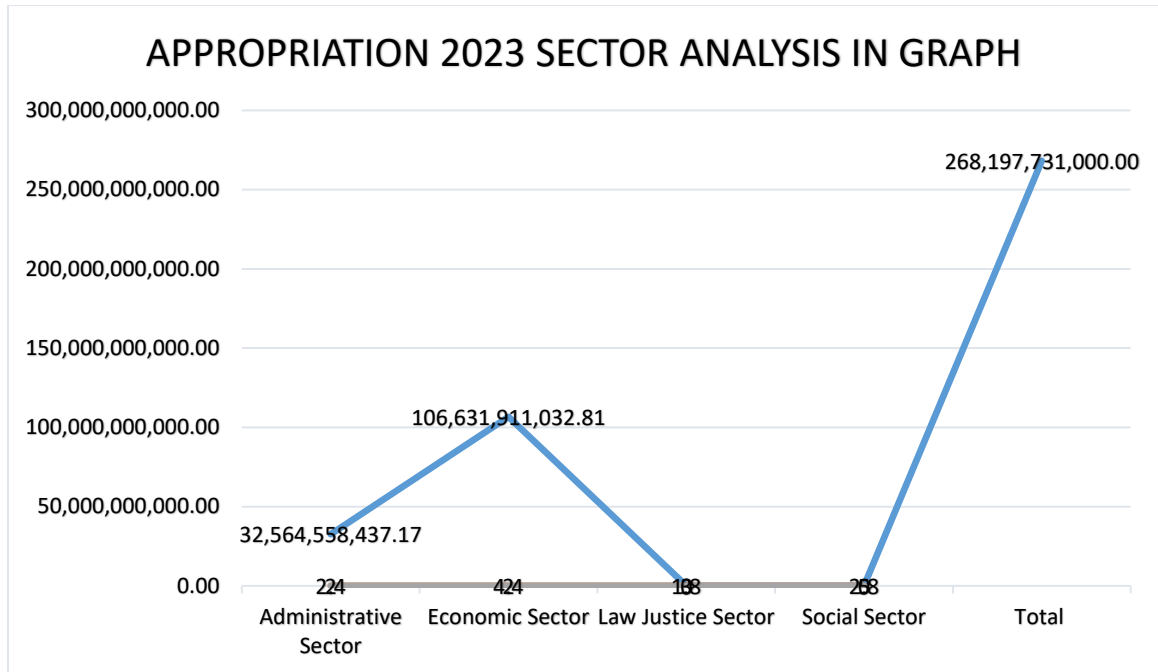
- The sum allocated for capital expenditure is significantly higher than the personnel and overhead cost put together.
